NEW BUSINESS

Consideration to Accept the Tentative Budget for Fiscal Year 2024-2025

Douglas reports that the Admin Committee recommends 12.7-million-dollar budget. This would include a 2% wage increase for employees and cover the increase in insurance. We are also budgeting for a new code enforcement officer to assist police & building departments. There is an ongoing need to budget for new municipal buildings like shop and library. The August Council meeting will solidify the budget. Cobb wants to make sure we hire a well-qualified candidate. Chief Twidt plans on thoroughly training the new hire.

Councilmember Douglas motioned to approve the tentative budget for FY 2024-25. Motion was seconded by Councilmember Mercado. Motion carried.

Consideration on Osburn Animal Control Agreement

Osburn raised their daily rate for dog impoundment. This shouldn't be too much of a problem for us, but we do use them as overflow.

Consideration on Animal Shelter Agreements with Osburn, Pinehurst, & Shoshone County

Chief noticed we need to update our agreements for dog impoundment to reflect new charges. We charge the County just the \$8 daily fee, which we bill monthly. Shoshone Pet Rescue takes care of cleaning, feeding and caring for dogs, for which he is very grateful, since it saves the city money.

Councilmember Douglas moved to approve the agreement. Motion was seconded by Councilmember Cobb.

Mayor's Appointment of Library Board Member

Kirby Gray submitted a letter of interest to fill the vacant position on Library Board of Trustees.

Councilmember Douglas thanked Mr. Gray for his interest and moved to approve the appointment of Kirby Gray to the Kellogg City Library Board of Trustees. Motion was seconded by Councilmember Teeters.
