

2024 CITY OF KELLOGG SCARECROW CONTEST OFFICIAL RULES

Scarecrows will be displayed around Kellogg through the month of October. **A registration form must be submitted no later than September 13th at 4:00pm** to the City of Kellogg during regular business hours, or via email to monica.miller@kellogg.id.gov.

The contest is open to Kellogg schools, businesses, organizations, and clubs. There is no fee for entry; only registered scarecrows are eligible for the contest and placement on city property.

All scarecrows must be placed the first week of October. The materials should be durable as they may be subjected to severe weather conditions. Scarecrow entry sponsors are required to monitor the state of their scarecrow for the duration of the exhibit.

Displays must be in good taste and appropriate for viewing by the public and families. Displays must be absent of adult, political and religious themes. No violent, gruesome or disturbing entries will be allowed. Scarecrows placed on or near sidewalks must not encroach into the walking path. The City reserves the right to remove any displays that violate these rules.

Scarecrows must be stuffed with straw. Free straw is available for pick up on the dates listed below. Commercially made scarecrows are not allowed. Prefabricated scarecrow frames will be available for purchase for \$5 each on a first come, first served basis.

Scarecrow placement locations

- Businesses *with* storefronts should place their scarecrow where it will be most visible to the public.
- Uptown businesses (Main/McKinley) may attach their scarecrow to the light post closest to their storefront.
- Businesses/groups *without* storefronts will be able to place their scarecrow in a location predetermined by the City.

Voting and announcement of winner

Voting on scarecrows will open on October 6th and conclude on November 8th. Votes can be cast by using a smartphone to scan a QR code attached to displays, or in the ballot box at City Hall.

Winners will be announced at the November 13th City Council Meeting. Scarecrows must be reclaimed over the first weekend of November. All scarecrows not reclaimed by November 11th will be removed and discarded.
