WHEREAS, Idaho House Bill 710 requires public libraries to adopt a relocation and removal policy to comply with Idaho Code 18-1514 and 18-1517b;

AND WHEREAS the Kellogg Public Library's Board of Directors has reviewed and approved the policy labeled Exhibit A;
